## **RESEARCH: Mild Cognitive Impairment Can Affect Medical Decision-Making**

According to researchers at the University of Alabama at Birmingham, patients with mild cognitive impairment (MCI) scored significantly lower than controls on measures for:

- Appreciating the consequences of a treatment choice
- Reasoning for making a particular treatment choice
- Understanding the treatment situation, treatment choices, and risks/benefits (Okonkwo, O., et al. Medical decision-making capacity in patients with mild cognitive impairment. *Neurology*. 2007 Oct 9;69(15):1528-35.) http://www.neurology.org/cgi/content/abstract/69/15/1528

**DID YOU KNOW...** the Mini-Mental Status Exam (MMSE) is NOT a test to determine one's capacity to make decisions, judgment and reasoning? MMSE tests for orientation, memory and language abilities. For purposes of capacity determination, Orange County Elder Abuse Forensic Center Psychologist, Bonnie Olsen, Ph.D. suggests

seeking a neuropsychological assessment to determine the client's capacity to make the particular decision in question.
